1 Preface 前言

This specification describes the type, dimension, performance, technical characteristics, warnings and cautions of the lithium ion rechargeable cell. The specification only applies to N18650CP cell supplied by Zhengzhou BAK Battery Co., Ltd.

2 Definition 定义

2.1 Standard charge method 标准充电方式

At 25 ± 2 °C, the cell is charged to 4.2 V at constant current of 0.5 C (1625 mA), then charged at constant voltage of 4.2 V until the current tapers to \leq 0.01C (32 mA) followed by resting for 5min.

2.2 Standard discharge method 标准放电方式

2.3 Nominal capacity 标称容量

Nominal capacity, signed as capacity and using mAh as unit, is obtained by discharging a cell via standard discharge method after it is standard charged.


